## POLICY FOR USING IT FACILITIES

This document details the policy for using the internet and computer facilities at Navjeevan Institute of Management, Nashik. These resources are provided to students and staff to enhance their academic, research, and administrative efforts. To maintain efficient, ethical, and secure use, all users must adhere to the guidelines outlined in this policy.

### \* Purpose of the Policy

- 1. Ensure fair and responsible use of the internet and facilities by students and staff.
- 2. Safeguard the college's network infrastructure and data.
- 3. Foster a conducive environment for academic and research activities.
- 4. Provide guidelines for the appropriate use of college resources.

#### Scope of the Policy

This policy applies to all students and staff members of NIM, Nashik who use the collegeprovided internet and facilities. It covers all devices connected to the college network and the use of college facilities for internet access.

#### Policy:

- 1. All users must use the internet and computer facilities provided by the institute exclusively for academic, research, and administrative purposes related to their roles at the institution.
- 2. Any use of the internet or facilities for illegal activities, including but not limited to hacking, copyright infringement, or distributing malicious software, is strictly prohibited.
- 3. Users should avoid accessing or distributing offensive, obscene, or discriminatory content.
- 4. Personal use of college resources should be limited to non-disruptive activities during designated break times.
- 5. Users must not engage in any activities that could compromise the security or integrity of the college's network infrastructure, such as attempting to bypass security measures or gain unauthorized access to restricted resources.
- 6. The installation of unauthorized software or hardware that may pose security risks to the network is prohibited.
- 7. Users should promptly report any security incidents or suspected breaches to the college administration.

- 13. Violations of this policy may result in disciplinary action, up to and including suspension of network access, academic penalties, or legal consequences, depending on the severity of the offense.

By accessing the college's internet and facilities, users acknowledge that they have read, understood, and agreed to comply with this policy.
